DEFINITION In this agreement, the term "Activities" shall include all activities in any way related to the outdoor sporting activities such as, but not limited to: skiing, running, inline, boarding, biking, surfing, paddling, skydiving, para-gliding, hiking, climbing, adventure racing, triathlon etc including, but not limited to, orientation and instruction sessions; photo, video or film shoots; event coverage; transportation or travel to and from the site; lodging; all activities while on site; or other activities offered by, or associated with XCZONE.TV.

ASSUMPTION OF RISK I am aware that Outdoor Activities involve many risks, dangers, and hazards including, but not limited to: accidents which occur during transportation or travel to and from the site; lodging; falling or collisions; impact or collision with rocks, trees, logs, dead-fall; environmental factors such as extreme temperatures, altitude, water, ice, avalanches; encounters with domestic or wild animals; negligence of others, negligence of other parties participating in activities offered by, or associated with XCZONE.TV. and negligence on the part of xczone.tv., including the failure by xczone.tv to safeguard and protect me from the risks, dangers, and hazards of outdoor activities.
